- 6) Vendor hours are 11:00 a.m.-6:00 p.m
- 7) At 6:00 pm you may begin to pack your items.
- 8) All tables in the **crafting area** must have table to floor, table cloths.

- 10) No alcoholic beverages will be sold or distributed by anyone other than BooB-B-Q and/or its affiliates.
- 11) No flammable items, hazardous materials, weapons, controlled substances, or similar materials are not permitted on the premises.
- 12) No one is permitted to dump any ashes, grease, or gray water anywhere on the event site except in the designated receptacles provided by BooB-B-Q.
